I mention this because Piatov talks in his article about the "Russian robbery of the Crimea in spring 2014". He claims that Russia has robbed the Crimea from Ukraine.

For this sleazeball, a referendum in which over 90 percent of Crimean residents voted for reunification with Russia is a "robbery" rather than a legitimate democratic decision.

But it is no robbery for him if the land of the Palestinians has been stolen without a referendum and without their consent for over 70 years. And even today more than ever!!!

This shows what an anti-democrat, hypocrite and representative of double standards Filipp Piatov really is. He is also a spin doctor and a propagandist and propagandist of lies, and therefore clearly NOT a journalist.

In his article Piatov writes that the company bosses would sit together with Putin, while "the security authorities in their home country fend off Russian state terror.

He is thus spreading the unproven assertion that "a Russian on behalf of the Kremlin murdered a Georgian in Berlin's Tiergarten."

However, if you look at the background of Zelimkhan Khangoshvili, it may be a case of blood revenge or honour killings because of his involvement in the "Lopota shooting". Khangoshvili was a known criminal and radical Islamic terrorist who left a long bloody trail of victims whose close relatives may have disposed of him.

Then the Georgian is said to have been involved in the attack on the father of the current head of the Chechen Republic, Ramzan Kadyrov. He also served as an informant for the Domestic Intelligence Agency. The suspected perpetrator is said to be Vadim Krasikov, who is wanted by the Russian authorities for the murder of a businessman in Mos-kau in 2013.

The murder took place on 23 August 2019, but the German authorities have not presented a single piece of evidence to date that the Kremlin commissioned the murder. In doing so, the Federal Republic of Germany insults itself as a "constitutional state", where the presumption of innocence should apply.

As is customary in the West, the Kremlin was immediately accused of having commissioned the work, and the Merkel regime also joined the prejudgement, "Moscow is to blame for everything and always" and two Russian diplomats are now expelled.

The West has long practiced the outrageous reversal of the burden of proof. Berlin simply accuses, and the Russian government is supposed to prove its innocence.

Russian Foreign Minister Sergei Lavrov said "You probably shouldn't talk like that to anyone, especially not to the Russian side."

But the fact that so far no evidence has been presented by the Federal Prosecutor's Office is worrying some German politicians.

"The fact that the German government is deporting two Russian diplomats, although the investigations are still ongoing, is difficult to understand without clear information," said Alexander Lambsdorff, deputy chairman of the Free Democratic Party (FDP), responsible for foreign policy.

From the beginning, the media began to make comparisons with the Scripal poisoning story about the Russian connection. However, there is only one similarity with the British case - no evidence was presented to the public, but the apportionment of blame began immediately.

For years there has been a "tendency to blame Russia for this and that, starting with the coup in Kiev and the crash of MH17 in Ukraine, the Skripal case and now this one," said Willy Wimmer, former Vice-President of the OSCE Parliamentary Assembly.

The German authorities who expelled the Russian diplomats must "say more", Wimmer continued, adding that "they must explain why they did it and whether there is really enough evidence to create problems for our diplomatic relations".

Therefore, perhaps the motive is quite different, namely to sabotage the economic relations between Germany and Russia. As is well known, Washington wants to prevent the completion and commissioning of the Nord Stream II pipeline.

This constructed case strengthens the Russian haters and gives them reasons to obstruct Russian energy supplies in order to import expensive American fracking gas.

How stupid and polluting is that? Not only because fracking poisons the soil and drinking water, but because liquefying and transporting the gas across the sea requires a lot of energy.

The first trip abroad in her new function as EU Commission President took Ursula von der Leyen to Ethiopia. There she first met the President of the African Union, Moussa Faki Maha-mat, and assured him that "Africa is more than just a neighbour".

Afterwards she was invited by the Ethiopian president and Nobel Peace Prize winner Aiby Ahmed. He revealed a rarely honest insight into the African soul with his statement: "We still demand more financial support because we are ambitious". At least we are quite ambitious when it comes to making demands - and at least these demands are being met by the EU in a way that is beneficial.

windfall profits from tax billions

According to this EU press report, von der Leyen has redistributed 170 million euros from the EU to Africa: 100 million for economic development, mainly in the transport and logistics sector, 50 million for a health reform in Ethiopia, ten million for improving the business climate in the country (!) as well as another ten million for a transparent course of the upcoming elections in the country in 2020 - a position, by the way, in which Germany is adding another ten million from its own pocket.

The fusion of man and machine in modern war technology

By 2050, the US military could be able to implement highly developed cyber technologies in combat units. A new study by the US Department of Defense reveals interesting, but also worrying facts.

More on the subject - Study criticizes Amazon and Microsoft because of development of dangerous Al combat systems

In its study entitled "Cyborg Soldier 2050: The Fusion of Man and Machine - Implications for the Future", the US Department of Defense's Working Group on Biotechnologies, Health and Human Performance examined several developments in the field of new technologies. These are intended to increase human performance and make it more effective in meeting military targets. The ethical, legal and social implications of these technologies are also being addressed:

The study group predicts that technologies to improve the interaction between man and machine will be generally available and continuously developed before the year 2050. This is largely due to civil demand in the bio-economy, which is in an early stage of development in today's global market.

Tactical advantages through neural networking

The analysis shows that the development of "direct neural connections of the human brain for direct data exchange will bring about a revolutionary improvement in military capabilities" in the future. In less than half a century, special neural implants in the wearer's brain would enable their interaction with weapon systems, reconnaissance drones and troops, the report says. Spatial distances no longer play a role, since the connections are established via a central network and the (military) Internet:

The possibility of direct data exchange between human neural networks and micro-electronic systems could revolutionize communication with tactical operational elements, accelerate the transfer of knowledge throughout the chain of command and ultimately minimize the uncertainties in warfare.

Brain implants and artificial eyeballs for special units

The procedure for implanting such a technology could be "invasive and include methods in which microelectrodes are implanted directly into regions of the brain or via the surface of the device.

brain," the report continues. Non-invasive methods, such as the use of electrodes on the scalp, can also be used.

In particular, Special Forces personnel would accept this type of technology, as it includes significant improvements in their own abilities, individual survival and overall battlefield superiority. Users would be offered "improved computing capabilities that allow identification, selection and sharing of data with other individuals or military systems". This would include enormous performance improvements in the field of vision, but would involve drastic invasive measures:

The eyeball itself is completely replaced and the data is transmitted directly to the optical nerve bundle behind the eye. The sensory inputs for visualization would be completely mechanical or electronic in composition, enabling data feeds of all kinds and across all spectra, including those that could not previously be visualized by humans. The development of high-bandwidth implantable interfaces that stimulate nerves at the individual neuronal level will enable bidirectional data transfer. In essence, the eye would be completely artificial and capable of receiving any kind of sensory data and feeding it directly into the brain for interpretation.

Social assimilation as a precursor

The report's disclaimer states that the research findings are "not an official policy or position of the US government". The US Department of Defense must first create a legal, security and ethical framework for these new technologies, it says. The Pentagon should also support further basic research on technologies for the fusion of man and machine "before they are used to provide long-term security and track their impact on individuals and groups.

However, the report also recognises the problem that the use of these technologies may not be accepted by the public. To counter this, "efforts should be made to reverse negative cultural narratives about the new technologies," the study group recommends:

More realistic and balanced reporting and transparency, which should serve to better educate the public about the introduction of these technologies, alleviate societal fears and remove barriers to deployment.

EU court promotes migration, EU Parliament insults Europeans as racists

The legacy on the back of the new EU Commission is huge masses of rock, not mere stones - and there is little hope that more reason will come out of Ursula von der Leyen.

For both the EU Court of Justice and the EU Parliament have recently acted as radical promoters of migration, completely against the will of the majority of Europeans. And the EU Parliament is

ever the first people's "representation" in history to publicly insult its own people, its own voters, as malicious racists.

Just over half a year has passed and "already" the EU has a new commissioner - not quite yet, of course: the British have not sent anyone, which makes the legal quality of the Commission questionable. But it doesn't matter, because things certainly can't get any worse in Europe than in the Juncker period.

Which is to say, correctly enough: It is by no means only the Commission that has often driven the people of Europe into despair. Often the things that the EU Court of Justice or Parliament do are much worse. Only they are not as conspicuous as the stupidities of the Brussels Commission. In reality, the Court and Parliament are much more dangerous, because with them the member states no longer have any way of slowing them down.

The main fault of both institutions is the promotion of the migration of peoples from Africa and Asia to Europe. As if it were their strategic objective to make the EU thoroughly miserable for Europeans.

First to the EU Court of Justice. This court recently ruled that an asylum seeker must be fully entitled to all material benefits in terms of accommodation, food and clothing even if he or she has behaved in a grossly violent manner. He may not even be expelled from an asylum seeker's quarters if he has instigated a brawl there.

The reason: the director of a Belgian asylum centre had thrown an Afghan out for at least two weeks after such a brawl. He was probably also acting on the basis of the experience that the European courts, which consider themselves humanitarian, only impose prison sentences when murder and manslaughter are involved (Margaret Thatcher would have called them "flannel courts").

But even such a harmless punishment for brawling is too severe for the EU Court of Justice: the EU states are obliged to permanently grant asylum seekers a "dignified standard of living". No further comment.

Even more shocking is a resolution of the EU Parliament, which demands a broad flight path for the migration of Africans towards Europe. Although this resolution was passed in the spring, it was completely swept under the carpet in the reporting of EU journalists, who of course know what such a text (note: see https://www.europarl.europa.eu/doceo/document/B-8-2019-0212_DE.html) would trigger in the European electorate.

Only now is it beginning to be known. It should be presented to the MEPs on a daily basis, together with the question of how they justify such a thing to their voters - and whether they have even read the long text before it was adopted.

In many passages, the long document goes far beyond the UN migration pact, which last year still met with a "no" from the Austrian government. The no' vote at that time was vehemently criticised by the Left. This year's EU resolution, however, no longer met with any resistance from Austria. Even the Freedom Party only abstained from voting! Which means that the Left has won through in the long term.

Just like the UNO pact, the EU resolution is not binding in the legalistic sense. But it is another big piece in the puzzle of a policy that is massively geared towards promoting further mass migration from Africa to Europe.

Due to their accumulation, such documents are constantly being used as a basis for argumentation, on which further concrete pro-migration judgements and measures can then be based. And above all, the "it is not binding" argument is absurd in itself: it in no way explains why such resolutions were adopted in the first place. It only confirms the suspicion of many Europeans that the Eurocrats are using a windy salami tactic.

In concrete terms, the text, with its EU-typical buzz and jingling of words, which is deliberately confusing, comes across as particularly scandalous:

It is provocative not only for Austrians that the EU parliamentarians refer several times to Europe's debts from colonial and slave-owning times. The vast majority of EU member states have never been colonially active and have never owned slaves. This turns the misconduct of some states at least 60 years ago into a current collective guilt of all (as if all 28 were responsible for Hitler or Stalin, for example, and still are today ...).

It is constantly claimed, using radical left-wing vocabulary, that racism in Europe is "structural" - without being able to name a single such structure in European laws. The MEPs see an alleged "structural racism" against people of African origin in almost all areas, specifically in "employment, education, health, criminal law, political participation" - and of course in "migration and asylum policy and practice".

The text is marked over many pages by the jibe that is part of the basic rhetorical repertoire of African politicians, that Europe is to blame for all the problems of Africans. Now, however, the EU-Europe is making it its own

At the same time, the line between the (actual or alleged) discrimination against the 15 million black Africans already living in Euro-pa today and an alleged right for people living in Africa to migrate to Europe is deliberately blurred, although the one has absolutely nothing to do with the other.

Of course, not a single syllable is used to refer to the persecutions that have been reversed in recent years.

white people - i.e. descendants of emigrated Europeans - have experienced in Black Africa, such as those in the Zimbabwe through numerous murders and state-ordered land expropriations, which have been

The results of the past decades have undoubtedly exceeded everything that has been done to Africans in Europe at the same time.

It is even complained without any proof that children of black Africans in Europe allegedly have lower school grades for no reason and are "clearly" more often drop-outs. The MEPs see this as the fault of the Europeans and not as a consequence of the lack of educational orientation of many African families.

Similarly, there are complaints - without the word "drugs" even being hinted at, of course - about "discriminatory checks and searches and surveillance".

Also condemned is "blackfacing" - the harmless blackening of the face during entertainment events or Epiphany actions - which would even "intensify" discrimination.

This absurd paranoia, which has now been adopted by the European Parliament, has even led to street battles in the Netherlands around the tradition of the "Zwarte Piet" in recent years, because many Dutch people do not tolerate such ideological interference in their traditions.

Quite parallel to the argumentation of feminists and Islamists in recent years, there are complaints that blacks are "massively underrepresented" in the legislative bodies.

At the very least, the EU parliamentarians' claim that Africans "have contributed significantly to the construction of European society" is astonishing. What does this mean in concrete terms? Perhaps the migration of people from East Africa via Asia Minor to Europe some 60,000 years ago (the descendants of these migrants only no longer have black skin colour today because they lived many generations in the harsh and colder European climate).

Europe should now - the "days" for all kinds of things are apparently no longer enough - introduce "months of black history". And one sentence later there is even a call for an official "Decade of the People of African Descent".

In the authorities, "training courses for the elimination of prejudices" are to be held and the teaching plans of the schools are to provide a "comprehensive" view of the topics "colonialism and slavery" (the apparently meant terms "re-education" and "brainwashing" do not yet occur directly ...).

As a matter of course, the document also calls for the "participation" of Africans in television and other media. In addition, the EU Commission should set up a special working group dedicated to the topic of "Afrophobia".

There is also a call for the creation of new criminal law paragraphs introducing new offences of opinion to punish "hate crimes" against Africans.

And the absolute climax can be found as the 23rd (out of a total of 28!) demands hidden: the EU Parliament "calls on the Commission and the Member States to ensure that migrants, refugees and asylum seekers can enter the EU safely and legally, taking into account existing legislation and procedures".

To reassure now outraged Europeans, some MEPs refer to "legislation and procedures". But that is completely naive. After all, the current laws have clearly only been able to prevent and slow down the migration of peoples a little because the existing legislation has not created "safe and legal ways" for Africans to migrate directly to Europe. As soon as they are in place, it is absolutely certain that the calculations based on serious studies, for example by Gunnar Heinsohn, will come true that hundreds of millions of Africans want to migrate to Europe.

And above all: "Existing" legislation can be amended by parliaments at any time! This resolution is virtually a clear call to do so. Left-wing politicians in several countries have already demanded the creation of such new legislation so that Africans can move to Europe "safely".

It is absolutely shocking that a large majority of the - elected by the Europeans! - MEPs do not understand all this or even deliberately ignore it.

It is just as shocking that there has probably never been a democratically elected representative body of the people, which has so aggressively challenged its own (!!) citizens and voters, especially its own teachers and officials.

siv as racists, as discriminators, as guilty of the problems of other continents.

It is shocking how much MEPs ignore the fact that Africa's economic and social problems have worsened in the 60 years since the end of colonial times, and that they do not mention with a single syllable that the Africans themselves have also made an incredible number of mistakes (through tribal and nationality conflicts, through the expulsion of white farmers, through socio-economic destruction, through Islamisation, through selling out to China ...).

It is depressing that there is not a single indication, let alone recognition, of how many billions of euros in development aid have flowed from Europe to Africa.

It is shocking how much the re-education actions demanded by the EU Parliament are carried by a very similar <spirit> (consciousness> as the totalitarian regimes of the National Socialists or Communists were, who also wanted to impose their own convictions on those subject to them.

It is an imposition on our intelligence to pretend - just as with the UN migration pact - that such a small reference to existing laws or to the lack of direct binding force would make such documents completely ineffective and insignificant. If they were, then there would be no need to adopt them in the first place. In truth, such resolutions are always an important mandate for the EU Commission, which is responsible for introducing laws and directives that are then fully binding, and no Commission has yet dared to ignore them. Every future Commission will have to report on what it has already done to implement this resolution.

And it is anything but comforting that the MEPs have adopted such an unbelievable text through the back door past the public.

Severe defeat for Nestlé: Michigan court revokes water rights

The fact that the Swiss food company Nestlé is a public water supplier is "absurd," said Jim Olson, an environmental lawyer from Michigan.

The Swiss food company Nestlé suffered a severe blow. The second highest court in Michigan ruled that the company's commercial water bottling was "not an essential public service", nor was it a public water supply.

The small municipality of Osceola wanted to prevent Nestlé from building a pumping station contrary to the applicable regulations. According to The Guardian, Nestlé's attempt to privatise the water is in jeopardy. For such plans, Nestlé would have to be declared a public water supplier providing an essential public service.

Michigan's environmental attorney Jim Olson, who does not represent the Osceola community but who has already litigated against Nestlé, said any claim that the Swiss company is a public water company is "absurd. This shows the extent to which private water marketers like Nestlé are trying to "privatise sovereign public water, public water supply and the land and communities". So far, Nestlé has been able to pump water in Michigan.

As a result of last Tuesday's ruling, state environmental authorities could now also reconsider their approval.

Review:

Nestlé had appealed at first instance against a decision of the municipality. In 2017, Nestlé wanted to increase its output from around 950 litres per minute to 1,500 litres per minute.

Because of the increased output, Nestlé would have had to build a pump on the site of a children's camping site in the municipality of Osceola. This was rejected by the community. At the end of 2017, the local court ruled that water is essential for life and that bottling water is an "essential public service". A victory for Nestlé.

Now the court of appeal ruled that water was indeed vital. However, it was not mandatory to market bottled water in which tap water is available.

For Nestlé is not a "public water supplier". According to national law, these are only companies that transport the water through pipes to a place - not in bottles. For commercial purposes, water pumping is prohibited. Nestlé now wants to consider possible further legal action. sua

Israel threatens Iran with pre-emptive strike and "its own Vietnam in Syria

Israeli Prime Minister Benjamin Netanyahu and U.S. Ambassador David Friedman will jointly watch a live broadcast of a test of the Arrow 3 missile defense system jointly developed by the U.S. and Israel (July 2019). Israeli Defence Minister Naftali Bennett has declared that Syria will become the Vietnam of Iran. He proclaimed: "We must move from containment to attack". Shortly before, the Israeli Foreign Minister had already threatened a pre-emptive strike.

Israel, which invades Syria almost daily and fires rockets at the war-ravaged country under the pretext of taking action against "Iranian positions" there, has warned Iran not to build "a ring of fire" around Israel. Tel Aviv threatened retaliatory measures if Tehran ignored these warnings.

Israel's Arrow-3 missile was tested in Alaska/USA on July 28.

It is no secret that Iran is trying to build a ring of fire around our country," Israeli Defense Minister Naftali Bennett claimed on Sunday.

Bennett, who is known as the war hawk, said that Iran is already established in Lebanon and is trying to establish itself in Syria, Gaza and other areas," Bennett, who said that the Israeli Defense Forces (IDF) "are working tirelessly" to fend off the alleged "Iranian threat," also said that it is high time for Israel to move from defense to offense:

We have to go from containment to attack.



He referred to the Vietnam War, which was catastrophic for the USA, in order to substantiate his position: We say to Iran: Syria will be your Vietnam.

Iran has repeatedly denied the allegations, pointing out that its military advisors embedded in the Syrian armed forces are legally in the country because they were invited by the Syrian government, unlike the Israeli forces, whose bombing of Syria is in flagrant violation of international law.

Bennett's statements come just days after Israeli Foreign Minister Yisra-el Katz threatened that Tel Aviv would not shy away from a pre-emptive military strike against Iran if the Israeli government estimates that Tehran is making progress in developing nuclear weapons:

A pre-emptive strike is one possibility. We will not allow Iran to produce or procure nuclear weapons. If the only option we have left is the military option, we will act militarily," Katz told the Italian newspaper Corriere Della Sera on Friday.

While the Israeli government, which is estimated to have a nuclear arsenal of 80 to 90 warheads, fuels fears of Iran's nuclear armament, it remains silent about its own efforts in this field. After a test of a mysterious "rocket propulsion system" by Israel on Friday, Tehran accused Israel of testing a "nuclear missile against Iran". It is believed that the Israeli military may have fired the little known Jericho ballistic missiles. These are said to be capable of carrying a substantial nuclear warhead.

According to WADA decision: Russia wants to fight for its athletes© Sputnik / Grogori Sysoyev

The World Anti-Doping Agency (WADA) has decided at its executive meeting in Lausanne to exclude Russia from the Olympic Games and World Championships for four years. According to Dmitry Svishtchev, a parliamentary deputy of the Duma's sports committee, Russia intends to appeal the decision to the International Court of Sport (Cas).

According to an announcement by WADA on Monday, Russia will be banned from major sporting events for four years and the Russian anti-doping agency (RUSADA) will be suspended until 2023. RUSADA will also have to cover all costs of WADA investigations incurred since January 2019 and pay a fine equivalent to ten percent of its 2019 income. However, clean Russian athletes should still be allowed to compete under a neutral flag.

WADA blocks Russia for four years

Furthermore, the Executive Committee has determined that Russian government representatives may not participate in meetings of the boards or committees of international sports organizations or be elected to their bodies during this period.

In addition to this, Russia is not allowed to apply for or host major sporting events during the period mentioned above.

The background to the decision was that the doping samples provided by the Moscow laboratory for the forensic investigations by WADA experts from 2012 to 2015 should have been "neither complete nor completely authentic". According to WADA, "hundreds of alleged adverse analytical results have been deleted or altered" and 145 alleged doping cases have been covered up or falsified.

In the run-up to the WADA decision, IOC President Thomas Bach had announced that he wanted to support "toughest sanctions" against Russia. "The WADA decision is binding for us", Bach had emphasized. Russia reacted to Monday's WADA decision by announcing that it would appeal to the International Court of Justice for Sport in Lausanne. Russia will fight for its athletes, said Parliamentarian Svetlana Shurova to the Interfax agency.

Sipri Report: Arms Exports Rising Worldwide - USA dominates the market by a large margin

In 2018, the largest arms manufacturers sold significantly more weapons than in the previous year. This is according to the report of the Peace Research Institute Sipri. Especially in the USA, exports are increasing strongly

- also because of an announcement from President Trump. In Germany and Russia, numbers are down.

The world's 100 leading arms companies increased their global arms sales by almost five percent last year. In 2018 they sold armaments and military services worth a total of 420 billion dollars (around 380 billion euros), according to a report published on Monday by the Stockholms Peace Research Institute (Sipri). This was an increase of 4.6 percent compared to the previous year, which according to Sipri was mainly driven by higher sales figures of the largest corporations. The report does not take into account goods from Chinese companies, for which there is still a lack of sufficient data for reliable estimates.

The absolute frontrunner in terms of sales remains the USA. For the first time since 2002 - since that year "Sipri" has had comparable data including material from Russia - groups based in the United States have all five top positions among the leading defence companies. These five - "Lockheed Martin", "Boeing", "Northrop Grumman", "Raytheon" and "General Dynamics" - together sold armaments worth a total of 148 billion dollars. In total, US companies accounted for \$246 billion, representing 59 percent of all top 100 sales and an increase of 7.2 percent over 2017.

Peace researchers see an important trend in the USA in the fact that larger arms companies are taking over smaller companies. "US companies are preparing for the new weapons modernization program announced by President Trump in 2017," said "Sipri" weapons expert Aude Fleurant. "Big US companies are merging to be able to produce new generations of weapon systems and thus be in a better position to win contracts from the US government.

Arms Exports in Europe

Europe accounts for a good quarter (24 per cent) of world arms sales. The 27 European arms producers included in the list sold goods worth 102 billion dollars, a slight increase of 0.7 per cent.

In contrast, the figures for the four listed German groups fell by 3.8 percent overall. Increasing deliveries of military vehicles from Rheinmetall to the German armed forces are offset by a decline in sales at the shipbuilder "Thyssen Krupp", said "Sipri" expert Pieter D. Wezeman. This gives Germany a 2.0 percent share of global arms sales, ranking behind Italy, Japan and Israel, but ahead of India and South Korea. In the "Sipri" evaluation, "Airbus" is listed as a "trans-European" corporation because the company is based in more than one country.

US weapons for Nato: Allies are fed up

The sales of British arms companies fell by 4.8 percent, among other things because of delays in their country's arms destruction programme, while those of French companies rose by 2.4 percent. Nevertheless, Great Britain remains Europe's number one arms seller, followed by Frank-

rich. Arms sales from Russia remained almost unchanged: the ten Russian companies listed in the top 100 sold goods and services with a total value of 36.2 billion dollars, a minimal decline of 0.4 percent. Five of the companies recorded increases, five losses.

Sipri" refers to any sale of military goods and services to military customers at home and abroad as arms sales. According to peace researchers, sales have increased by a total of almost 47 percent since 2002.

"Is that fair? It's arbitrary!" - German sports lawyer on the exclusion of Russia

German sports lawyer Christoph Wieschemann, who among other things represented Russian cross-country skier Ale-xander Legkow before the International Court of Justice for Sport (CAS) in Lausanne, considers the new punitive measures against Russian athletes to be illegal. In his statement he explains his reasons.

Even before WADA's decision announcement on Monday, Christoph Wieschemann had already commented on the recommendation of the WADA Compliance Review Committee (CRC). In this recommendation, the Committee had proposed punitive measures against Russia, its athletes, government representatives and federation representatives for the duration of four years.

In the statement of 6 December 2019, which is available to Sputnik's editorial staff, Wiesche-mann describes the proposed measures as "manifestly illegal, if not arbitrary". This approach would rather expose the double standards prevailing in the fight against doping than strengthen credibility.

"The fact that Travis Tygart, the USADA chief, of all people, is particularly prominent here, condemns a certain sense of disruption. Before RIO 2016, US athletes had used 'Therapeutic Use Exemptions', banned substances with or without an expired TUE, on a large scale. Internal USADA e-mail traffic documents that the practice was known but not stopped. Even the big leagues in the USA have not yet submitted to the WADA code and the USADA, which accepts this," says the sports lawyer.

Richard McLaren has always stressed that his report is neither intended nor suitable for punishing individual athletes. Furthermore, in the Legkow v. FIS decision, the CAS stated that although the McLaren report contained some suspicious facts, these were not sufficient for a conviction. The athletes were later acquitted by the CAS and the ruling in the appeal proceedings was also confirmed by the Swiss Federal Supreme Court at the request of the IOC. The McLaren Report referred, among other things, to the diary entries of Grigory Rodchenkov, the chief witness, of which Rodchenkov himself later admitted to have falsified them.

WADA decision: Whistleblower Rodchenkov demands retroactive sanctions. Putin considers legal action.

"The legally binding evidence that has been ruled unsuitable, the McLaren Report, is once again becoming the benchmark for the admission of Russian athletes to competitions through the recommendation of the WADA CRC.

Whoever is named in it is out, even if he has already lost two years of his career, until he was cleared of any suspicion in the last instance, despite his mention in the McLaren Report. This is astounding," says Wieschemann.

The attorney recalls the circumstances set forth in the CAS ruling in the case of Alexander Legkov v. the International Olympic Committee, under which an athlete can be held liable for the exchange of urine samples at all:

"In the opinion of the Panel, an Athlete can only be held liable for the replacement of his or her urine by another Person if (a) the Athlete has committed an act or omission that facilitates such substitution; and: (b) he or she did so with actual knowledge of the likelihood that such substitution would take place. Only an Athlete who himself or herself commits an act that contributes to his or her urine Sample being subsequently substituted by another Person, and who knew or should have known that such substitution was likely to occur, is guilty".

Nevertheless, WADA recommends that the CRC expel athletes whose samples have been adulterated. This could potentially result in thousands of clean athletes being excluded because third parties have accidentally or intentionally manipulated their data without the consent or knowledge of the athletes. "Is that fair? It is arbitrary," Wieschemann judges.

According to the sports lawyer, there is no legal basis for excluding Russian government representatives from international sports events, as the Olympic Charter is not applicable to government representatives. In addition, the Russian state is not a signatory of the WADA Code and is therefore not subject to the criminal authority of WADA.

He was also left speechless by the attempt to clear the reputation of the "whistleblower" Rodchenkov in the public eye:

"Grigory Rodchenkov was not only at the centre of the doping system, he demanded money from the athletes for the cover-up of positive doping results and got it. This was not only a doping violation. That is punishable in just about every country, including Russia. Even 'Icarus' (the documentary, editor's note) does not hide the fact that Rodchenkov did not leave Russia to reveal the truth to the world public, but for fear of prosecution in Russia. It was the media that made him a whist-leblower.

The lawyer also criticizes the fact that there is talk of a "state" doping system in Russia. To date there is no evidence that "a member of the government or an employee of a ministry was not involved in the system out of criminal profit, but as part of the government's actions".

"The supposed fight of sport against doping in Russia has become or was from the beginning a narrative. The way in which it is dealt with damages the fight against doping in general. The narrative is kept alive in a cacophony of daily outrage by media representatives and stake-holders of different interests whose main theme, sometimes even their only theme, is exactly this or another doping scandal, and who outdo each other in demanding ever more severe punishments. In the face of the expectations thus created, any prudent, possibly acquitting verdict must appear deficient and 'unjust', as an expression of a lack of willingness to punish doping sinners," Wieschemann describes the current situation.

A system was necessary which did not focus on the interests of the federations competing for authority, but on those of the athletes.

Crime scene in Berlin-Moabit (Archive) Why was the Georgian murdered in Berlin not extradited despite Moscow's requests?

Andrej Hunko, spokesman for European policy of the Left parliamentary group in the Bundestag, has commented on the murder case in Berlin Moabit and the latest statements by Russian President Vladimir Putin to the Ria Novosti agency.

The left-wing politician stressed that Putin had not said that the Georgian's death in Berlin's Tiergarten was a "contract killing" or that "the Russian authorities were behind it".

"And above all, he offered help in clarification, and this must be taken note of," says Hunko.

The politician finds it "naturally very unfortunate" that the whole situation is "overlaid" by the expulsion of the diplomats. He called for an investigation of the incident and pointed out certain "open questions".

"But of course there are some questions. Well, Putin also said that there had already been a request for extradition as far as this person was concerned, and why this was not implemented now. These are just open questions that need to be clarified.

Relations with Moscow should also in this case be based on "cooperation" and "not on diplomatic escalation".

Murder in Berlin Park

On 23 August, Zelimkhan Khangoshvili, a 40-year-old ethnic Chechen of Georgian nationality, was shot dead in a park in Berlin. The German Federal Prosecutor calls the victim "Tornike K." The perpetrator - allegedly a 49-year-old citizen of Russia - was caught the same day and has been silent ever since.

The Federal Prosecutor's Office took over the case on suspicion that state authorities in Russia or the Chechen Republic had commissioned the murder. German Chancellor Angela Merkel accused Russia of not helping in the investigation of the murder.

Georgian killed in Berlin organized terrorist attacks in Moscow subway

Vladimir Putin had called the Georgian murdered in Berlin's Tiergarten a fighter and organizer of explosions in the Moscow subway at a press conference after the Normandy meeting in Paris in the night to Tuesday. He said that 98 people had died in one of the terrorist attacks that the murdered man had helped organize.

Moscow had addressed several requests to Berlin for the extradition of the organizer of the terrorist acts in the underground. However, the German side did not comply with Russia's request. Russia would nevertheless help its German colleagues in the investigation of the case.

Russia's response measures

Putin described the expulsion of Russian diplomats from Germany on the basis of only preliminary findings as incorrect and announced countermeasures. German diplomats would be expelled from Russia. However, the president did not believe that the case would plunge Russian-German relations into a crisis.

Pentagon is on alert: Almost 50 percent of US soldiers consider Russia an ally

According to a survey by the Reagan Institute, almost half of all US military establishments regard Russia as an ally rather than a threat. A Pentagon spokeswoman attributes this phenomenon to "Russian disinformation". Once a year, the Reagan Institute conducts the "National Defense Survey" to ask Americans about their attitudes to war and peace and other political issues. For the US

One aspect in particular stands out from the most recently published results of the survey conducted at the end of October: the relationship of US soldiers and their family members to Russia.

According to the survey, 46 percent of soldier families in Russia see Russia as an "ally", while 53 percent consider Russia as an enemy. In the total population, however, only 28 percent consider Moscow an ally, while for families without military personnel the figure is 25 percent. China has now pushed Russia from first place in the category "greatest threat" and is named as such by 28 percent of respondents (Russia: 25 percent). Extract from the National Defense Survey.

Among republicans there is a somewhat more positive image of Russia than among democrats. 29 percent of supporters of the "Grand Old Party" consider Moscow an ally, while among Democrats only 23 percent share this view.

Warsaw lightsaber rattle: Poland demands NATO armament in space against Russia

Traditionally, military personnel tend to vote conservatively, i.e. republican, which is one explanation why almost half of the soldiers and their families see Russia as an ally. Another explanation was provided by a spokeswoman for the Ministry of Defence, where there is apparently concern about the positive image of Russia within the troops.

There are efforts by Russia to flood the media with disinformation to sow doubt and confusion," Lieutenant Colonel Carla Gleason told Voice of America.

The Russians, according to Gleason, "do this through false narratives designed to evoke unacceptable sympathic views."

But how do the "false narratives" get into the heads of the soldiers? Jorge Benitez, military-analyst and employee of the tightly anti-Russian-oriented think tank Atlantic Council, has an explanation for this: they would be given to the troops by Kremlin-led hackers, pro-Russian media and "President [Donald] Trump's positive statements about Russia". "This is dangerous," Benitez told Voice of America. According to Gleason, the US military is "actively working to expose and combat Russian disinformation. She did not give any further details. Last weekend, US Secretary of Defense Mark Esper declared that the US military, despite the volatile situation in the Middle East, now wants to focus on Russia and China. The comparatively positive image of Russia within the troops is not exactly conducive to this refocusing. The figures brought to light by the Reagan Institute are alarming for the Pentagon for another reason as well: no other state institution enjoys such trust among the population as the military, which 86 percent regard as trustworthy (in comparison: Supreme Court 62 percent, Congress 33 percent). There is therefore a danger that the pro-Russian views, which are rooted in the armed forces, could "skip over" to other population groups.

This is a clear violation of the UN Charter, which must allow all diplomats free access to the international organisation.

The visa application was submitted a few weeks ago, before the last escalation, and would allow the Iranian top diplomat to present the Iranian view on the assassination attempt to the representatives of all countries.

"They are afraid that someone will come to the USA and reveal the reality", said Zarif after he was denied a visa. He vowed to communicate with the Americans from Tehran, noting that "the world is not limited to New York".

Although Trump has claimed in 2019 that he does not want "no war with Iran," he has been sending thousands of soldiers since

months in the Middle East:

The West is calming down after US President Trump's decision to refrain from new military actions against Iran for the time being. But the "powder keg on which a new world war could ignite remains," says left-wing politician Sahra Wagenknecht. She calls on the German government to draw very specific consequences.

Despite the Iranian retaliatory attack on US troops in Iraq, the immediate danger of a new war in the Middle East seems to have been averted for the time being. US President Donald Trump had announced new economic sanctions against Iran in an address to the nation on Wednesday, but no further military strikes. This was tied to Trump's conditions that Iran must stop its nuclear program and be prepared to cooperate.

Reasonable doubt?

Sahra Wagenknecht, former chair of the Left Fraction in the Bundestag, again doubts that the situation will deescalate prematurely. She explains on her Facebook page that the current situation has certainly not only kept her on tenterhooks in the last few days. She does not believe, however, that the "fuse on the powder keg", which was extinguished with the "irresponsible and illegal assassination" of the Iranian general by the USA and the "irresponsible and illegal attacks" of Iran on US bases in Iraq, has been erased:

"The powder keg from which a new world war may be ignited will remain. And I cannot imagine what would have happened if the Iranian attacks had caused many casualties..." The question remains as to which of the two actors will keep their nerve and which will possibly lose it.

US nuclear weapons out of Germany...

According to Wagenknecht, the federal government must now finally draw the consequences. This includes, among other things, bringing all soldiers from the Middle East to Germany: "And it should take a courageous initiative to save the nuclear agreement with Iran. To set an example, it should push through that all nuclear weapons are finally withdrawn from Germany!

Earlier this week, the left-wing politician had also noted on Facebook that Trump's intentions in the Middle East were not peace but war.

The role of the media...

Wagenknecht also drew attention to the role of German media. There the targeted Killing of Iranian General Soleimani often justified with the fight against terror:

"A particularly bold lie. As the Iraqi prime minister informed the parliament there, Soleimani was in his country because of bilateral peace efforts with Saudi Arabia, mediated by Iraq."

According to the members of the Bundestag, it was obvious that the USA feared that the Middle East would finally come to rest. Because then, according to Wagenknecht, they would be able to sell fewer weapons and the US military bases and troops would become superfluous.

USA "create terror"...

According to Wagenknecht, the USA would not fight against terror, but would create and practice it itself - with "wars contrary to international law and criminal drone killings" on foreign territory:

"Germany and the EU need an independent foreign policy that respects international law and democracy. ... This includes closing US military bases on German soil so that they can no longer be used for wars and drone killings in violation of international law.

Wagenknecht demands a minimum of attitude and backbone from Chancellor Angela Merkel and Foreign Minister Heiko Maas. Germany must not let Donald Trump drag it into a big war, but must do everything possible to prevent it.

Merkel and Putin - surprisingly friendly meeting in Moscow

The meeting between the Chancellor and the Russian President in the Kremlin on Saturday - only a few days after the assassination of Iranian General Kassem Soleimani - had something of an appeal against further escalations.

You rub your eyes. Was there something? A crisis between Russia and Germany? The deportation of diplomats? Serious accusations against the Russian authorities for the murder of a Chechen in Berlin's Park Tiergarten? None of this could be heard in the Kremlin on Saturday, at least not at the press conference after a three-and-a-half-hour conversation between Putin and Michael. At the press conference it became clear that the two politicians are now putting aside their differing views on all the issues discussed - from Iran, Syria, Libya and Ukraine to Nord Stream 2.

sions, in favour of goals that can be achieved together. It is possible that the two leaders, with the unity demonstrated in Moscow, also want to send a signal to the USA not to go too far with the detonation in the Near and Middle East.

Solutions for several conflict regions discussed

At the press conference, Angela Merkel expressed her thanks "for the opportunity to have a comprehensive discussion on bilateral cooperation as well as on international issues. Despite "some difficulties in connection with the sanctions related to Ukraine" - said the Chancellor - there is "intensive economic relations between Russia and Germany, but also in the field of science and universities.

The Chancellor stated that the Nord Stream 2 project is an "important economic project" that is "legitimised by European jurisprudence". Despite American sanctions against the pipeline, she said it is possible "to complete the construction of Nord Stream 2". With Russia and Ukraine having agreed on transit supplies for the next five years and the Turkish Stream pipeline being opened, fears of unilateral dependence on gas supplies are unfounded, she said.

Vladimir Putin explained that he expects Nord Stream 2 to be completed by the end of this year, beginning of next year. The Chancellor said she hoped that the efforts of Putin and Erdogan to establish a ceasefire in Libya would be successful. A waf-fencing cease-fire is to come into effect in Libya on Sunday at noon. Merkel went on to say that she agreed with Putin "that an invitation to a Libya conference in Berlin could be issued very soon". At this conference, "under the leadership of the United Nations" peace was to be achieved in the North African country.

The Chancellor sees the greatest danger in other states interfering in Libya's affairs. She did not say which states these are. But she apparently meant Turkey in particular. Merkel said that a peace solution in Libya would have to include the parties in Libya "who are involved in the military conflict". This would involve "Messrs Sarradsch and Haftar". Putin welcomed the German initiative for a Libya peace conference.

Merkel praises Putin and Erdogan

The Chancellor stated that the talks between Putin and Erdogan on Syria had "brought important results". She is pleased that two border crossings to the Idlib region are now open again for humanitarian supplies. She said that there was "a great need" in this region. "As in Libya, there would be "no military solution" for Syria either, but "ultimately only negotiated solutions". Germany is committed to a further humanitarian transition in eastern Syria. In addition, Germany supported the project of a constitutional convention for Syria and would work "very, very closely" with Russia, Turkey and France on this project. The Syrian leadership did not mention Merkel in this context. A political solution was necessary "so that people who have fled Syria can return. Especially many refugees are in Turkey, the Chancellor said.

Regarding Iran, Merkel said that Germany wants to maintain the nuclear agreement with Iran. Iran should "not have nuclear weapons". Regarding the airplane disaster near Tehran, the Chancellor said that Iran had admitted that the shooting down was "a big mistake". She said it was good that "those responsible are now known". Now the shooting must be "ruthlessly cleared up" and "the consequences must be discussed". In Iraq, he said, the aim was to "further enable" the fight against Islamic terrorism. Merkel did not say exactly what she meant by this. Apparently, however, the Chancellor believes that German military trainers must continue to be stationed in Iraq. But she can hardly count on Russian support in this matter.

Putin warns of new streams of refugees

The Russian president declared that there was war in the Middle East. But so far, he said, it's not much of a war. If there is a big war, it will be "a catastrophe not only for the Middle East, but for the whole world." Then there would be new refugee flows, "not only in Europe, but also in other regions". There will be "humanitarian, religious and economic catastrophes".

Regarding Ukraine, Merkel explained that at least an exchange of prisoners had been achieved by the end of the year.

She hopes that at the next meeting in Normandy format "further progress in the order of Minsk agreements" can be achieved.

Journalist asks: "Cooperation EU-Russia against the USA?"

A journalist from the German private broadcaster RTL asked the Chancellor whether it was possible to prepare for the fact that there would be cooperation between the EU and Russia in the future, "possibly also in some questions against the USA? Merkel replied that, as she explained using Nord Stream 2 as an example, there were "differences of opinion with the USA, although they are our allies". Germany represented its interests and Russia represented its interests. With Russia there would be opposing opinions, but there would also be "overlaps". With regard to the nuclear agreement with Iran, he said that they "basically agree with Russia." A conversation - like now in Moscow - has the advantage "that you talk to each other and not about each other." Whether it is Iran, whether it is Libya or Syria, "there will be military action for quite some time. But in the end, the only solution will be political."

Before the meeting of Putin and Merkel, Russian media gave reasons why the chances for a rapprochement between Russia and Germany are good.

As far as Iran is concerned, "the interests of Russia and Germany coincide," writes the news agency Ria Novosti. Russia and Germany fear the outbreak of a major war near their countries. The USA would be geographically less affected by such a war.

European business has a great interest in the Iranian market, Ria Novosti continues. The nuclear agreement with Iran opened up the possibility of investing in Iran. But this opportunity is now being blocked by the unilateral cancellation of the nuclear agreement by the US.

The forecasts for Germany's economic development are poor at one percent growth. In the first ten months of 2019, trade between Russia and Germany had fallen by twelve percent. The German economy therefore urges - according to Nezavisimaya Gazeta - to end the sanctions against Russia.

The paper quotes in detail from a study by the Berlin Foundation for Science and Politics, according to which the conflict between Iran and the USA can also lead to conflicts in other Islamic states from Afghanistan to Iraq and Lebanon. The flow of refugees from these states to Europe could increase.

Russian media had reported before the meeting of Putin and Merkel that the initiative for the meeting had come from the Kremlin, immediately after the murder of Iranian General Soleimani. Later, Putin's spokesman Dmitry Peskov stated that the agreement for a meeting between Putin and Merkel had already been made last year.

Russia represented by a large delegation

The Russian side was represented by a large delegation at the meeting with Angela Merkel. While Putin spoke with Merkel, the foreign ministers of Russia and Germany, Sergei Lavrov and Heiko Maas, met in parallel. In the Kremlin hall, where the press conference was held after Putin and Merkel's meeting, I saw Gazprom boss Alexei Miller in cheerful conversation with Russian Foreign Minister Sergei Lavrov and Russian Minister for Economic Development Maksim Oreshkin. Also present in the hall were Russian Deputy Energy Minister Pavel Sorokin and the Russian Ambassador in Berlin, Sergei Netschayev.

From the German side I saw apart from the Federal Chancellor only her spokesman Steffen Seibert. During the press conference Heiko Maas demonstratively did not join the group of Russian delegation members - where the German ambassador in Moscow, Géza Andreas von Geyr, was already standing - but went, all alone and undaunted, to the other side of the hall, where employees of the German embassy in Moscow and German journalists had gathered. The lonely march of the German Foreign Minister seemed strange. Source: https://www.nachdenkseiten.de/?p=57602
